Update on the Boundary Commission Review for Somerset.

The deadline for stage 1 of phase 2 of the consultation was extended by the Boundary Commission (at the request of Somerset Council) to 4 March 2025. Somerset Councils submission was agreed at the Constitution and Governance Committee on 3rd March for submission by the deadline on the following day.

Supplement 1 - Appendix A has the details of the proposed structure of electoral divisions. The overall electorate of Somerset, based on the projected 2030 figures is 467,274; the target figure for 96 divisions per member was 4,867, and the Council has endeavoured largely to stay within 10% of that figure.

Somerset Recycling sites Now Operating on Spring/Summer Hours.

All 16 of Somerset Council's recycling sites have reverted to their spring/summer opening schedule on 1 April. Sites will be open from 9am to 6pm Monday to Friday and 9am to 4pm at the weekend.

Opening days vary across sites midweek, however all sites are open on a Saturday and Sunday.

Materials accepted at recycling sites will vary, residents can check ahead before they visit as there are queue cameras at Bridgwater (Saltlands), Chard, Highbridge, Minehead, Street, Taunton (Priorswood), Wellington (Poole), Wells (Dulcote), and Yeovil (opening days vary) - <https://www.somerset.gov.uk/bins-recycling-and-waste/recycling-site-queue-cams/>

Dog Control Order Currently out for Consultation – Somerset South Dog Fouling and Somerset South Dog Exclusion Ninesprings.

The Council is proposing to extend two existing orders; the first relates to a dog exclusion zone in part of the Ninesprings Park in Yeovil while the second covers dog fouling and keeping dogs on leads in public places across the former South Somerset District Council area.

The existing Public Space Protection Orders (PSPOs) are due to expire, and the Council is seeking the public's views on extending the orders for a further three years.

The **PSPO** relating to Ninesprings covers the lower lake area and would bar people from taking dogs into the zone. Assistance dogs are exempt. The area is rich in wildlife and the order aims to protect the habitat.

The second **PSPO** relating to dog fouling and keeping dogs on leads aims to protect the public and local wildlife. The consultations run until **5 May 2025** and can be accessed via the following links:

Somerset Council Lib Dem Administration is One of Only 6 English Councils to have been given permission for an increase above the 4.99% Council Tax Cap – Approving a 7.5% Council Tax increase In addition to needing government support to close this years remaining gap of £43m.

The £43m budget gap will be bridged using a Capitalisation Direction which is a form of one-off assistance (that was also requested last year) offered by Government which allows the Council to continue to sell off assets or borrow money in order to use the proceeds to fund this years budget gap for day-to-day running costs.

The Council also applied to the Government for financial support and whilst it asked for permission for a 22.84% increase in Council Tax, **it has been allowed to increase Council Tax by 7.5%**. This sees a band D property paying an additional £129 a year. For many homes in Somerset this will be in addition to very large increases in some Town and Parish elements of the Council Tax including an annual increase of £111.73 (Band D) in Bridgwater making it one of the most expensive in the country.

Somerset Council's new and increased car parking charges spark outrage and despair.

The Liberal Democrat run Somerset Council have announced their intention to introduce a new parking policy that will see residents across the county pay more for parking. At the Executive Meeting on 3 March it resolved to

- EXPAND Sunday charges covering the whole county.
- NEW on-street parking charges – e.g. parking bays/Blue Anchor

Following considerable challenge from Councillors it was decided to not proceed with NEW overnight charges.

So what happens next - these proposals have been supported by the Councils Executive and they are all now subject to a formal consultation process.

Once resources have been secured the draft parking orders will be prepared – it is anticipated that this will happen in May with bespoke notices being produced for each location with specific changes being identified. This will provide more of the detail.

The public 6 week statutory consultation will then follow, possibly commencing in mid to late May. This will be followed by a review of the responses to determine whether they can proceed as planned or whether changes, including mitigations are needed. The decision will then be made as to whether to proceed or not. The final decision will then be made by the Executive possibly during August or September – dates yet to be confirmed.

Somerset Council is undertaking a formal review into the local government and electoral arrangements for Langport and Huish Episcopi.

The Community Governance Review (CGR) has been triggered following a valid petition from people living in both existing local council areas, calling for the current local councils to be dissolved in favour of a single parish, in the interests of efficiency and cost effectiveness.

The review will start by consulting key stakeholders including the MP for Glastonbury, the elected members for the Curry Rivel and Langport divisions at Somerset Council, Huish Episcopi Parish Council and Langport Town Council. Issues that will be considered as part of the review include the number of new councillors for the new parish council and whether it should be divided into wards.

Final recommendations are due to be considered by Somerset Council this autumn, with implementation of the decision to be effective from April 2027. Anyone wishing to make written representations on the review should do so via email at cgr@somerset.gov.uk.

FREE Drop in Events for Somersets Unpaid Carers.

Unpaid carers in Somerset were invited to join Somerset Council, Somerset NHS Foundation Trust and Community Council for Somerset (CCS) for a series of drop-in sessions throughout 2025.

The first of the series took place on Monday 31 March at Minehead Eye in Minehead. Anyone who is looking after someone else in an unpaid capacity is welcome to come along to these free events, even if they are receiving Carers Allowance.

Future dates will be announced - events will include a series of free seminars on a range of topics which cover areas frequently asked about by unpaid carers, including Lasting Power of Attorney, Direct Payments, Finances, and Guardianship. Adult Social Care staff will be present to help guide unpaid carers through questions they might have. Other organisations will also be there to give free information and advice, including:

Somerset Council is introducing support and improvements to bus services across the county following confirmation of a new £6 million tranche of Government funding for 2025/26.

Initiatives under Somerset's Bus Service Improvement Plan (BSIP) will incorporate improved services for Yeovil and Bridgwater including evening journeys, continued evening services for Taunton and on-going support for vital bus routes across Somerset including in Frome, Dulverton and Wiveliscombe.

In line with bus priority measures at traffic signals in Taunton, similar schemes are to be rolled out in Yeovil and Bridgwater. These will help buses avoid delays and should help ensure timetabled stops are more reliable.

Taunton's Park and Ride fare will remain £1 for a single journey as part of the package. With the end of the £1.50 fare trial in Taunton on 31 March, bus users are encouraged to check operators websites for up-to-date fares. The government's £3 national fare initiatives continues until 31 December 2025.

Somerset Council is introducing an innovative new system in Taunton to give buses priority at traffic lights and encourage more people to bus it to town.

Work started on 24 March on signals along East Reach to install new technology which will see a smart system effectively link oncoming buses with the signals and enable the lights to change to allow them through.

The system aims to improve travel times for passengers and help operators avoid delays. It is part of Somerset's Government-funded Bus Service Improvement Plan (BSIP).

The Council's contractor will need to carry out some phased initial work at 3 sets of lights on East Reach between **24 March and 16 April**. During the day 2-way traffic will be maintained. There will need to be some lane closures during the evening between **6pm and 11pm** while work is undertaken under temporary lights.

The initial work is scheduled to take place at the following locations:

- South Street / East Reach junction: 24 March – 8 April

- Haydon Rd / East reach junction Civils Works – 1 April – 9 April
- Victoria Gate junction Civils Works: 10 April – 16 April

The new signals will then be installed during June and July under a temporary traffic lights system specially designed to minimise disruption.

Taunton's main library in Paul Street will be closed for 2 days in April while Somerset Council carries out important upgrades.

The library, and The Glass Box innovation space, will close their doors on **Wednesday and Thursday 9 and 10 April** for a major IT network and Wi-Fi hardware and systems improvements.

This will strengthen security and improve Wi-Fi and network capabilities for customers in the future.

The library will reopen at **9.30am on Friday 11 April**.

Somerset County has published major new plans for safe cycling and walking routes in the county's towns to help create greener, healthier and more active streets.

The Local Cycling and Walking Infrastructure Plans (LCWIPs) for Wellington, Chard, Burnham and Highbridge have been published.

The Council has already created and published plans for Yeovil, Taunton, Bridgwater and Frome.

The **LCWIPs** are focused, 10-year plans for developing a cycle and walking network within each local area. The aim is to secure funding over the next decade for significant new safe routes for cyclists and pedestrians across all Somerset's towns.

These are evolving plans which will continue to develop over time, with the views and suggestions from the public central to the process.

Having a plan in place is key to unlocking Government funding to build the infrastructure and enable people in Somerset to choose to walk or cycle to work, school, the shops or for other short trips for the benefit of people's health and the environment.

Expanding the active travel network is an essential part of Somerset Council's strategy for developing sustainable transport. The Council has worked closely with Local Community Networks, cycling charities and local cycling groups to develop the plans.

Yeovils Active Travel Routes Near Completion - with the final road closures and upgrades having started on the 17 March

Two Somerset Council Active Travel schemes – pedestrian and cycling – in Yeovil town centre are nearing completion. Diversions will be in operation and any affected bus routes will be re-routed. The team on site is liaising with business owners and residents affected by these closures.

South Western Terrace / Central Road / Middle Street / Old Station Road Central Road will be closed for up to 1 week to enable resurfacing of the carriageway and upgrades to traffic signals. Consecutively and to make best use of this closure, a series of night time only closures in South Western Terrace / Middle Street will also be in operation for new road crossings to be installed as part of the signals upgrade. A final night time closure will be in place for final surfacing and road marking.

Hendford - On Hendford, the focus has been the creation of a shared cycling and walking route. To complete the final phase of works here, a full road closure will be in place northbound from Brunswick Street to Hendford Medical Centre from **Monday 24 March to Friday 4 April**. Additional travel time is recommended due to the diversion route.

At the northern end of Hendford, temporary traffic lights remain in place to enable completion of works in that area. The carriageway will be fully resurfaced following the works, which will conclude the works in Hendford. The date for the final surfacing will be shared in due course.

Pen Mill link - Further minor repair works are planned on the Country Park link to Pen Mill railway station. These will be completed in the coming 6 to 8 weeks with no road closures needed. Residents should not see any significant disruption while these are being undertaken.

Elsewhere in the country School Streets have been proven to achieve this. The School Street at Bruton Primary School launched on Monday 13th January 2025 and we are now seeking feedback on the trial scheme. – **Closes 13 July 2025**

Somerset Tree Planting Register

Somerset Council published a 10 year Tree Strategy in June 2023 to enhance and protect Somerset trees and woodland across the county.

Amongst its ambitious aims, the strategy sets out a plan for planting 240 hectares of new trees and woodlands each year across the county until 2033.

From Somerset's famous apple orchards to Exmoor's mighty oaks, the aim is to increase the county's tree coverage from its current 8% to the national average of 13% and more if possible.

We know there are many groups, farmers, residents, organisations and businesses that are involved in planting trees and hedgerows, so it's important that we record and celebrate their efforts.

By mapping your tree planting, it will help us to know if the county is on target to meet its important planting goals.

Why your views matter - We are building a map of new tree planting across Somerset. We would like to hear about tree planting activities you are involved with, to allow us to measure the increase of Somerset's tree coverage and recognise the collective efforts of the people of Somerset. **Closes 31 Jan 2033**

A38 Improvement Scheme – Closes 24 March - Somerset Council (SC) is working in partnership with North Somerset Council (NSC) on a funding bid to deliver a series of improvement schemes on a stretch of the A38 which runs from the Edithmead Roundabout at Junction 22 of the M5 to the South Bristol Link (Colliters Way).

Many junctions along the route are operating close to capacity leading to varying travel speeds, limited accessibility for pedestrians and cyclists, unreliable journey times and congestion at peak times, along with potential road safety issues.

Post 16 Transport Scheme – closes 20 March - Policy Statement annually, setting out the arrangements for enabling eligible Post-16 (aged 16-18) and Post-19 (aged 19+) learners to access further education.

The Council is proposing to make a significant change to the policy, a statutory consultation is required to inform the decision process required to publish the Policy Statement in May 2025.

A Fire Service Consultation relating to responses to Automatic Fire Alarms Closes 9 April 2025 Devon and Somerset Fire and Rescue Service has started a consultation with options to change how we respond to automatic fire alarms.
