### 41/25 Planning Applications

### 25/00826/FUL Crauchan Blacklands Lane To Forton Lane Forton TA20 2NA

What is proposed? Erection of a machinery barn

Councillor S Adams left the meeting and sat in the public area

Access is no longer through the hedgerow but via the drive to the bungalow.

The meeting was opened to the public

The owner explained that the barn will be for storage and repair of his vintage tractors, which is his hobby. The access past his bungalow is narrow; there is no room for a lorry. It is not a working farm. The barn is a similar size to the previous application but repositioned due to the change of access. The ecological report recommended that the rest of the area remain as grass and trees to screen from neighbours.

The meeting was closed to allow the Councillors to discuss

Proposed by Councillor K Patay, Seconded by Councillor R Down. 4 in favour, Councillor Adams did not vote.

**RESOLVED:** Now that the access has been resolved Tatworth and Forton Parish Council supports the application.

### 25/00628/FUL Land Opposite Perry Street House

**What is proposed?** Demolition of Existing Barn and Equestrian Arena, Change of Use from Agricultural/Equine to C3 Residential and Erection of Two Dwellings (Revised information rec'd)

The application has been returned to the Council with amendments; however, the Councillors were unable to determine what has changed.

Proposed by Councillor P Chapple, Seconded by Councillor K Patay. 4 in favour with one abstention.

**RESOLVED:** The Parish Council were not able to make a comment because they were not given clear information, and would recommend that Planning make it clear when changes to previous applications are being considered what those changes are.

### 42/25 Other planning matters that councillors wish to report

Councillor P Chapple Questioned the notification issued by Planning

concerning Wreath Lane with the terms "for notification only". Upon checking the Clerk confirmed it was a "Certificate of Lawfulness". However, the Councillors were unaware what that term means. This will be another question to the Planning officer when they attend the meeting.

Councillor K Patay In Forton the Manor Farm development is

progressing but the actual listed farmhouse remains a ruin. Councillor R Down remembers that the developers are allowed the leave the renovation until the last new property has been sold. The Clerk will investigate this with Listed
